## Innocent Unborn Alaskans Deserve Protection

The Alaska Supreme Court has overturned every attempt by Alaskans to provide even modest protections for preborn children. They have literally manufactured a "right to abortion" in our Constitution that is clearly not there. Because of the unprecedented activism by the National Education Association (NEA) and many, if not most, public school administrators, teachers and counselors, Alaska needs a robust school choice option for parents concerned about the ideologies being taught in classrooms that are antithetical and indeed, hostile, to a Christian perspective. The Alaska State Constitution, as it is currently written, prevents the majority of our population from accessing private education opportunities. Ultimately, parents, not the Government, should have the primary responsibility for training their children. A Constitutional Amendment is our best hope for slowing down the Left's incessant determination to indoctrinate Alaska's youth.



## Our Judicial Selection Process Does Not Reflect the People

"Furthermore, you shall select out of all the people able men who fear God, men of truth, those who hate dishonest gain; and you shall place these over them as leaders of thousands, of hundreds, of fifties and of tens." **Exodus 18:21** 

During the original delegation of the Alaska State Constitution, outside consultants from the Lower 48 were called upon to provide a report to the delegates on their view of how judges were to be appointed in our new state. The consultants provided the following words of wisdom – "No state constitution has ever gone this far in placing one of the three coordinate branches of Government beyond the reach of Government controls. We feel that in it's desire to preserve the integrity of the courts, the convention has gone farther than is necessary or safe in putting them in the hands of a private, professional group..." This consultant report never even made it to the floor for the full delegation to consider. And since that time, conservative Governors have been unable to place judges in place with a strict constructionist or original intent judicial view. The only way to provide balance to the court is to amend our Constitution through a convention.
